5. Validity conditions:

- The certificate shall only promote its holder, the product and production places mentioned therein.
- The transmission of this certificate to third parties is inadmissible as well as its use by third parties.
- Any changes of product compared to certified product have to be forthwith announced to TÜV SÜD Czech. This circumstance may cause the continuation of the certificate dependent on additional conformity evaluation.
- The certificate shall only be reproduced complete including all the annexes.

This language version of the certificate is a translation of a Czech official version No. 07.865.724 issued on 19.03.2015, which is deemed the only one applicable in the event of legal disputes and was printed on 12.05.2016.
